

Camp Rental Group Program Guidelines

- 1) This program applies to rental groups leasing the camp premises during the camp's "off-season" who are unable to supply the camp with a certificate of insurance evidencing liability coverage with either due to the size of the group or coverage is with a carrier that is not A.M. Best rated A- or better.
- 2) A separate policy will be issued in the name of the camp that will have the "rental group" listed as an additional insured for the dates of the rental.
- 3) Normal camp coverage endorsement (Sexual Abuse or Molestation coverage, Medical Personnel as AI, etc.) will not apply to the rental policy.
- 4) For reporting purposes, the camp will report each months activity on the 1st of each month (i.e.: send in a tentative schedule for the 1st month of the policy term, then follow up the first week of the next month with an actual schedule for the proceeding month and a tentative schedule for the next month.
- 5) The camp may elect to activate the policy with a \$250 minimum earned deposit and report on a case-by-case basis when the need to add a rental group arises or pay the amount equal to the first month's activity (\$250 minimum), whichever is greater.

CAMP RENTAL GROUP PROGRAM

EXPOSURES: Facility Rental Group Attendees
EXCLUSIONS: Mechanical Amusement Rides, Sexual Abuse and Molestation, Additional Insured: Medical Personnel, Damage to Leased Premises

This page applies to rental group activities held on the camp premises during the off-season that are not sponsored by the Insured and for which a certificate of insurance is not available from the rental group.

LIMITS: \$2,000,000 General Aggregate Limit
\$1,000,000 Products-Completed Operations Aggregate Limit
\$1,000,000 Each Occurrence Limit
\$1,000,000 Personal and Advertising Injury Limit
\$100,000 Damage To Premises Rented To You Limit
\$5,000 Premises Medical Payments Limit

RATES: Per head attendance up to 1,000 total attendees. Subject to a per event minimum premium.

EVENTS: Activities available to rental groups including the following:

Class 1: convention; festival (art, craft, harvest); graduation; meeting (business, civic clubs); picnic; prom; religious assemblies; reunion (family or class); seminar; social gathering/reception; speaking engagement/lecture; wedding & reception.

Class 2: charity/school carnivals (no rides); concerts (bluegrass, country & western, jazz, pop rock); dances; evangelistic meetings; political rally; school band/drill team competition.

Class 3: horseback riding; groups with pool and/or lake privileges; ropes/confidence course instruction; scouting jamboree; sporting events.

NOTE: Each Business or Civic Group renting the facilities for more than one time (i.e.: monthly or weekly) meetings/seminars will be subject to one minimum premium provided annual attendance does not exceed 1,000 attendees.

A Commercial General Liability Minimum Earned (Deposit) Policy Premium of \$250.00 will apply.
